## Schuylkill County Response to Coronavirus COVID-19

The Schuylkill County Emergency Management Agency in consultation with the Pennsylvania Department of Health is actively working to plan and respond to the potential impact of Coronavirus COVID-19 with all County School Districts: Blue Mountain, Mahanoy Area, Minersville Area, North Schuylkill, Pine Grove Area, Pottsville Area, Saint Clair Area, Schuylkill Haven Area, Shenandoah Valley, Tamaqua Area, Tri-Valley, Williams Valley, and the Schuylkill Intermediate Unit and Schuylkill Technology Center. County Emergency Management and Superintendents continue to meet regularly to share information regarding these potential impacts.

State and local health officials continue to urge residents to practice preventative steps such as:

- Frequent hand-washing with soap and warm water for at least 20 seconds
- Avoiding close contact (within six feet) with people who are sick
- Avoiding touching one's eyes, nose, and mouth
- Staying home when sick
- Covering one's coughs or sneezes with a tissue and throwing the tissues in the trash
- Cleaning and disinfecting frequently touched objects and surfaces with household cleaning sprays and wipes

Much remains unknown about COVID-19, including fatality rates. Early indications are that children are at a much lower risk of severe illness from COVID-19, and as with influenza, the elderly and those with immunosuppressive conditions are at a higher risk of severe illness.

The County and all School Districts will continue to work collaboratively, proceeding with an abundance of caution, guided by the most current accurate information. We urge all residents of Schuylkill County to remain aware of the situation, follow recommendations for limiting potential infection and exercise good common sense. We want people in Schuylkill County to be aware of the situation but not panic.

# SCHUYLKILL COUNTY PANDEMIC ACTION PLAN

## A UNIFIED APPROACH BETWEEN SCHUYLKILL COUNTY SCHOOL DISTRICTS AND INTERMEDIATE UNIT, AND SCHUYLKILL COUNTY EMERGENCY MANAGEMENT

### MONITORING

- **School in session**
- The County and schools are monitoring activities (locally and regionally)
- Provide preventative education campaign
- Initiate Pandemic Preparedness Plan
- Implement Policy on Emergency Preparedness Plan
- Consider postponing student and staff travel in areas that are a focus of infection; reschedule as possible
- Consider denying district access to groups that have traveled from areas that are a focus of infection

### LIMITING

- **School in session**
- Consider postponing outside groups' events in our buildings; reschedule as possible
- Consider limiting audience attendance at school activities
- Consider suspending student and community volunteers
- Consider denying district access to groups that have traveled from areas that are a focus of infection

### POSTPONING

- **School in session**
- Consider postponing all athletic and extracurricular activities; reschedule as possible
- Consider postponing all district-sponsored events; reschedule as possible
- Consider postponing all travel and field trips; reschedule as possible
- Consider suspending Community Based Instruction

### CLOSING

- **School buildings closed**

#### FOLLOW GUIDELINES FROM CDC AND PA DEPARTMENT OF HEALTH

- **MANDATORY 14-DAY QUARANTINE FOR ANY STAFF MEMBER OR STUDENT WITH A CONFIRMED CASE OR LIVING WITH SOMEONE WITH A CONFIRMED CASE OF COVID-19**
- **MANDATORY 14-DAY SELF-QUARANTINE AND MONITORING FOR STAFF MEMBERS OR STUDENTS THAT TRAVELED TO/FROM OR WHO HAVE SOMEONE LIVING WITH THEM WHO HAS TRAVELED TO/FROM CDC DESIGNATED LEVEL 3 AREAS**
